

## **ZAGG LIMITED WARRANTY**

This limited warranty guarantees that Your screen or case protection product will provide coverage against defects described below during the warranty period, which period shall be defined in or on Your original product packaging or **purchase receipt valid for one (1) year and one (1) claim from the date of purchase.**

**Register Your Product Guarantee:** Please note: Your smartphone or tablet device must pass any required mobile app diagnostic test then You must register Your product registration code using the Warranty Life Mobile application available in iTunes and Google Play. **You may obtain your registration code from [warrantylife.com/zagg](http://warrantylife.com/zagg), within the thirty (30) day designated timeframe from Your date of purchase** as indicated on Your product packaging prior to any claim. Failure to do so will void the limited warranty. This limited warranty is non-transferable and only applies to the original purchaser.

If the protection product is defective when received, or becomes defective during the manufacturer's warranty period, it will be replaced in accordance with manufacturer's original factory warranty. You should contact Your point of purchase.

If the protection product is properly installed and Your device experiences screen breakage, or material damage to the screen, We will repair or pay You up to the amount promised as indicated on the product packaging only. This limited warranty does not cover liquid damage, fraudulent and/or intentional damage.

This limited warranty is effective from the date of purchase, provided the purchase receipt are kept and that protection products are installed and maintained properly when able to be determined by the Warranty Life app. WarrantyLife.com must be notified within thirty (30) days of purported failure, and all records be made available for inspection and verification of defects by our administrator. This limited warranty is exclusive and in lieu of all other warranties, including any warranty of merchantability or fitness for a particular purpose except where prohibited by law.
